On 01/04/2018 at approximately 1335 case Manager [redacted] spoke Monterrosa, Laura to AM, 212963376 about missing meals			
[redacted] stated, "I have ask you into my office to discuss the reason for missing dining meals. We discussed this the other day. When you miss 2 or more meals I have to talk to the residents. You missed more than 2 meals from Tuesday and Wednesday. Did you eat commissary in the dorm as an alternative for each one of those days?"			
[redacted] stated, "yes, I have not been going to dining."			
[redacted] stated, "you ate something in the dorm. Ms. [redacted] said she saw you eating in the dorm."			
[redacted] stated, "I eat what they give to me. I don't have commissary."			
[redacted] stated, "You don't have any money in your commissary."			
[redacted] stated, "No."			
[redacted] stated, "Other residents give you commissary to eat though?"			
[redacted] stated, "I was getting something to eat from someone, but the person she was getting it from does not have any more money."			
[redacted] stated, "It is that you don't like the food in dining."			
[redacted] stated, "Yes I don't like the food in the dining. If I didn't like the food in the dining, I would not have eaten since I have been here. I am not on a hunger strike. The reason I don't go to dining and to the recreation in house use of the officer [redacted] about anything else except have you eaten or not."			
[redacted] stated, "I am giving the reason why I am not going to the dining, which you should know."			
[redacted] stated, "you can go to dining and scan for fruit and bring it back with you. You don't have to stay in dining."			
[redacted] stated, "I am afraid that I am going to run into her. I have run into her in the dining and in recreation and that is why I have not gone there. I have encountered in the hallways. I am afraid that I am going to run into her again."			
[redacted] stated, "So I have to make sure that residents ate something that is why I am asking. Can no one send money as they were before?"			
[redacted] stated, "Why?"			
[redacted] stated, "I was just asking so that you could have commissary."			
[redacted] stated, "No."			
[redacted] stated, "Just understand that if you miss 2 meals again, I will be talking to you again."			
[redacted] stated, "I have already told you why I am not going to dining. It is a very strong reason why I am not going to dining. The investigator said to confess everything and that I was never going to see [redacted] eggs in. But that didn't happen because I still see her in the hallways and in the dining."			
[redacted] stated, "I am not going to discuss your case with you. I am just asking why you have not gone to dining. I will pass this on to the person who I have to give these report to."			
[redacted] stated, "You ask me why I don't go to dining and I am giving you a reason."			
[redacted] stated, "I will document your reason and I will pass it on as I do every ones."			
[redacted] stated, "I am going to speak about this to my lawyer."			
[redacted] stated, "You can do that. I am just asking why you are not eating and I have to talk to everyone who is on the list for not eating as I do everyone's."			
[redacted] stated, "I am giving you the reason and you are not wanting to listen to me."			
[redacted] stated, "I understand that your reason is that you are afraid that you are going to run into her in dining and recreation and hallways."			

Resident stated, "I have run into her."
Condo stated, "I will let someone know that this is happening."
